### High Representative Ashton confirms commitment to BiH's EU path



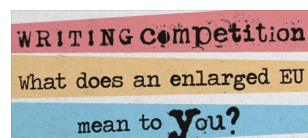

The presentation of the EU funded business plan for the restructuring of the Mostar International Airport was held on 7 March 2014 in the premises of Mostar City Hall.

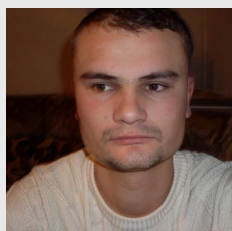


### EU supports entrepreneurial learning in the educational systems in BiH

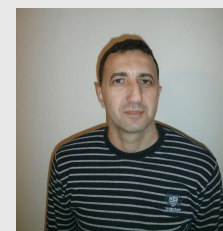
