In February she visited Brussels and Strasbourg in the framework of the EU Visitors Programme (EUVP), which aims to enable young leaders and potential leaders in government, politics, media and other fields from countries that are not EU members, to visit EU institutions and increase mutual understanding between professionals from outside the EU and their EU counterparts.



EU Floods Recovery Programme invests 1,6 million EUR to furnish and equip schools and kindergartens damaged by floods

The EU Floods Recovery Programme has invested EUR 1,6 million to provide furniture and equipment to a total of 124 kindergartens and primary and secondary schools, which are attended by an estimated 58,500 children and pupils across the flood-affected areas in Bosnia and Herzegovina.

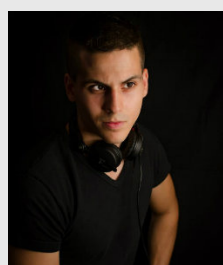


EU launches support project to phytosanitary sector in BiH
