CONTRACT SPECIFICATIONS

6. Description of the contract

Supply of specialized equipment to microbiology laboratories in Bosnia and Herzegovina in order to enhance capacity of health care system in B&H to respond on possible threat of easy transmissible communicable diseases.

7. Number and titles of lots

Lot 1: Supply of HVAC Equipment & Sanitary Equipment

Lot 2: Supply of Laboratory Equipment, Laboratory Furniture, and Other Laboratory Equipment

Lot 3: Supply of Electro-Security Equipment

TERMS OF PARTICIPATION

8. Eligibility and rules of origin

Participation is open to all legal persons participating either individually or in a grouping (consortium) of tenderers which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the IPA programme under which the contract is financed (see item 22 below and

http://ec.europa.eu/europeaid/work/procedures/implementation/eligibility/index_en.htm ; and go to **Instrument for Pre-Accession Assistance (Council regulation (EC) N° 1085/2006- OJ L210/82 of 31.7.2006).**

All goods supplied under this contract must originate in one or more of these countries. Participation is also open to international organisations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.

9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the *Practical Guide to contracts procedures for EC external actions*.

10. Number of tenders

Tenderers may submit only one tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

11. Tender guarantee

Tenderers must provide a tender guarantee of **400 Euro for Lot 1; 4000 Euro for Lot 2 and 350 Euro for Lot 3**. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties. This guarantee will be called upon if the tenderer does not fulfil all obligations stated in its tender.

12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee of 10% of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next best compliant tender.

13. Information meeting and/or site visit

No information meeting/site visit is planned

14. Tender validity

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders.

15. Period of implementation

120 days from signature of the contract by both parties.

SELECTION AND AWARD CRITERIA

16. Selection criteria

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

The proposals will be evaluated in accordance to the following criteria:

1) Economic and financial capacity of bidder

- the average annual turnover for the past 2 years (2006,2007) must exceed the total value of the financial proposals for the Lots offered by the bidder.

2) Professional capacity of tenderer (based on i.a. item 4 and 5 of the Tender Form for a Supply Contract)

- the tenderer has a minimum of 3 staff employed full-time.

3) Technical capacity of the bidder based on (i.a. items 5 and 6 of the Tender Form for a Supply Contract)

a) The tenderer has successfully completed at least 2 contracts of a total price amounting 80% of his total financial proposal for the Lots offered, within the past 36 month to the launch of this tender

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Under the same conditions, a consortium of economic operators may rely on the capacities of members of the consortium or of other entities.
