CONTRACT SPECIFICATIONS

6. Description of the contract

This contract will be implemented through "design and build" methodology. The Contract will cover reconstruction and construction of sewage network as described in the available feasibility study. More specifically, around 4560 meters of sewage network is going to be reconstructed in six streets in the central part of the city of Niksic. New construction will cover around 11860 meters of the sewage network in the same city area with another 9700 meters of network in the suburbs.

8. Eligibility and rules of origin

Participation is open to all legal persons [participating either individually or in a grouping (consortium) of tenderers] which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see also heading 22 below). All works, supplies and services under this contract must originate in one or more of these countries. Participation is also open to international organisations. The participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.

9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Works Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the **Practical Guide to contract procedures for EC external actions.**

10. Number of tenders

Tenderers may submit only one tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot. Tenderers may not submit a tender for a variant solution in addition to their tender for the works required in the tender dossier.

11. Tender guarantee

Tenderers must provide a tender guarantee of 70,000.00 Euros when submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties.

12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee of 10% of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

14. Tender validity

Time period envisaged for implementation of this contract is **18 months**.

SELECTION AND AWARD CRITERIA

16. Selection criteria

The selection criteria for each tenderer are as follows (in case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole):

Economic and financial capacity of candidate:

- a) the average annual turnover of the tenderer in the past 3 years must be at least 6,000,000.00 EUR
- b) the tenderer must have access to sufficient credit and other financial facilities to cover the required cash-flow for the duration of the contract. In any case, the amount of credit available must exceed the equivalent of 1,000,000.00 EUR

Professional and technical capacity of candidate:

- a) it must have completed at least 3 projects of the same nature/amount/complexity comparable to the works concerned by the tender over the last 5 years. The Contracting Authority reserves the right to ask for copies of the respective certificates of final acceptance signed by the supervisors/contracting authority of the projects concerned.
- b) it must have completed at least 2 projects of the same nature/amount/complexity comparable to the services (Design) concerned by the tender over the last 5 years. The Contracting Authority reserves the right to ask for copies of the respective certificates of final acceptance signed by the supervisors/contracting authority of the projects concerned.
- c) it must carry out at least 70% of the contract works by own resources, which means that it must have the equipment, materials, human and financial resources necessary to enable it to carry out that percentage of the contract.
- d) if it is the lead member of a joint venture/consortium, it must have the ability to carry out at least 50% of the contract works by its own means.
- e) if it is a partner of a joint venture/consortium (i.e. not the lead member) it must have the ability to carry out at least 10% of the contract works by its own means.
- f) all its key personnel must have at least 5 years' appropriate experience and proven qualifications relevant to works of a similar nature to this project.
