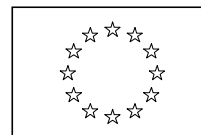

Ministry of Regional Development, Forestry and Water Management of Republic of Croatia and the Delegation of the European Commission to Bosnia and Herzegovina in cooperation with Directorate for European Integration of Bosnia and Herzegovina are seeking Grant Application Proposals within IPA Cross-border Programme Croatia-Bosnia and Herzegovina 2007-2013 (financial assistance from the 2007 and 2008 allocations) with the aim to encourage the creation of cross-border networks and partnerships; to encourage the development of joint cross-border activities with a view to revitalizing the economy, protecting nature and the environment and increasing social cohesion of the programming area. Under this Call for Proposals an indicative amount of 3.600.000 €, equally divided per country, is available for project proposals from both partner Countries (1.800.000€ for Croatia and 1.800.000€ for Bosnia and Herzegovina).
