Instead, once transaction is processed between bidder (Oracle partner) and Oracle, End User (HJPC) will receive Welcome Letter from Oracle Support containing Customer Support Identifier (CSI number) as a confirmation of support activation for purchased licenses.

## **Question 4**

- 1. Section "Platform characteristics" of the specification lists the following requirement: SCORM 1.2 Certified and AICC compliant.
- Q: In case all content-generation tools offered in the proposal produce SCORM-compatible content, and given that AICC is very uncommon and outdated format, is it satisfactory to offer SCORM-only compliance?

## Answer 4

It is acceptable to offer SCORM compatible content as must. AICC compliance can be optional.

## **Question 6**

- 3. Section "Course creation and administration" of the specification lists the following requirement: ADL SCORM® player ADL SCORM® 1.2 compliant.
- Q: Is it satisfactory if system is compliant and certified against newer edition of the SCORM (i.e. ADL SCORM 2004)?

## Answer 6

ADL SCORM® player must be ADL SCORM® 1.2 compliant. It is also acceptable that it is compliant with newer ADL SCORM 2004.

## **Question 7**

- 4. Section "Assessment" of the specification lists the following requirement: Import QTI questions into LMS quizzes or export LMS quizzes to QTI.
- Q: In case contractor is not already in possession of QTI questions, can this functionality be considered and listed as optional?

## Answer 7

As it is written in the technical specification software solution must support functionality "Import QTI questions into LMS quizzes or export LMS quizzes to QTI.", so it can not be considered and listed as optional.

## **Question 8**

5. Section "Collaboration and communication" of the specification lists the following requirement: *Online Conferencing tool integrated to Microsoft® Live Meeting or Cisco Telepresence solutions.* 

Q: Is it satisfactory to offer online conferencing tool utilizing newer generation of Microsoft's communication platform (MS Lync Server?)

## **Answer 8**

It is satisfactory to offer online conferencing tool utilizing newer generation of Microsoft communication platform such as Microsoft Lync Server.

## **Question 9**

**5.1. Specification:** Import QTI questions into LMS quizzes or export LMS quizzes to QTI.

**Question**: Could we use other formats for import/export questions (Aiken, Gift, XML) for implementing LMS?

#### Answer 9

It is acceptable to use formats (Aiken, Gift, XML) for import/export questions for implementing LMS.

## **Question 10**

**5.1. Specification:** Online Conferencing tool integrated to Microsoft® Live Meeting or Cisco Telepresence solutions.

**Question**: LMS that we offer has integrated Web Conferencing System - BBB (Big Blue Button) which is adapted to LMS and as such meets all the functionalities specified in tender documentation.

Is it necessary to do further integration with the above mentioned tools, because it requires additional engagement of developers, and in reality it only would be duplicating functionalities for web conferencing?

# Answer 10

It is not necessary to do further integration if the software solution has integrated Web Conferencing System which meets all functionalities specified in tender documentation.

#### **Question 11**

**5.1. Specification**: Create SCORM courses from existing content.

Question: Is it necessary to include 3rd party software for creating Scorm course, in offer?
