7. **Contract description:**

These terms of reference provide the grounds for the preparation of preliminary studies and designs for the betterment of the main roads M-5 and M-16 on the SEETO comprehensive network route 2a, namely the Lašva–Jajce–Ugar (inter-entity boundary line — IEBL)–Banja Luka–Banja Luka bypass (the 'Project'), totalling: L = 168,0 km, namely:

— component 1: Lašva–Donji Vakuf–Jajce–Ugar (IEBL), length = 114,0 km,

— component 2: Ugar (IEBL)–Banja Luka–Banja Luka bypass, length = 54,0 km.

The assignment of the consultant shall involve the provision of professional consulting services for the preparation of preliminary studies and designs in accordance with the laws applicable in Bosnia and Herzegovina; in particular, in the Federation of Bosnia and Herzegovina (component 1) and in Republika Srpska (component 2), in accordance with applicable standards and regulations, international standards and recommendations, related designs and required special requests of the contracting authority.

The project shall provide for, among others: a technical study, a traffic study, a multi-criterion analysis, a pre-feasibility study, a preliminary environment impact assessment for sections subject to new construction of roads (new alignment), an environment management plan for sections subject to existing road reconstruction (realignment), a preliminary socio-economic impact assessment for the betterment/reconstruction of the road, and terms of reference for the provision of the preliminary and main design.
