The first study on Floods and Landslides Risk for the Housing Sector in BiH produced by the **EU Floods Recovery Programme**

This is the first multi-hazard risk assessment done in the country that provides information to all levels of government and enables them to develop future disaster risk reduction policies and decisions. It concludes that harmonisation of legislation and implementation of concrete measures are necessary for future floods and landslides preventions.



EU facilitates changes to Anti-Discrimination Law in BiH

A conference on the BiH Anti-Discrimination Law was held on 15th December 2015 in Sarajevo. The aim of the conference was to present a gap analysis, and to draw up a list of recommendations as part of the technical support to the reform process. It was organised within a Framework Contract funded by the EU under the Instrument for Pre-accession Assistance, and implemented by **B&S** Europe experts.

Historic climate deal in Paris: EU leads global efforts

The deal is the culmination of years of efforts by the international community to bring about a universal multilateral agreement on climate change. Following limited participation in the Kyoto Protocol and the lack of agreement in Copenhagen in 2009, the EU has been building a broad coalition of developed and developing countries in favour of high ambition that shaped the successful outcome of the Paris conference.
